1. Elections to the Board

2. Reporting on work of the organisation in previous year:

Chair tabled and spoke to document: Digital Rights Watch 2016 Annual Report

First year of operations has been difficult to prove the financial viability of the organisation. Several unsuccessful pitches to philanthropic organisations and individuals, both here and overseas.

Board took a decision mid-year to shift focus away from securing funds and instead increase output of reports, submissions, media and campaigns.

This will be used to go back to potential funders and prove the work we do as an example for future funding pitches - both for core funding as well as project based.

We have secured strong partnerships with domestic organisations and institutions (QUT, Deakin, Thoughtworks, HRLC, Amnesty) as well as international (Access Now, Fight for the Future, Article 19) that have enabled us to have greater reach and impact than we would ever have achieved on our own.

3. Future workplan of organisation

Chair and Deputy Chair updated members on future workload and plans for the organisation:

- Strategic focus on financial sustainability for Digital Rights Watch
- Explore legal action to challenge mandatory data retention regime (currently under scope in partnership with the HLRC)
- Operate a watchdog on social media platforms ability to protect freedom of speech
- Expand our outreach operations to reach more audiences and empower them to understand and protect their digital rights
- Work with local and global partners to create educational resources for Australian markets
- Provide regular public policy updates
- Create a forum that helps coordinate the work of digital rights advocates in Australia (potentially could be a good source of sponsor funding)
