- Maybe shift from seeking core funding towards project funding? Seek margins on individual project grants that can build reserves for the organisation.

- What about fee for service models such as developing tools and technology that we seek profits from advocacy organisations to fund DRW? This may take us away from core mission work.
- We should also look at in-kind partnerships that can lend us support eg support from Thoughtworks to date.

#### 3. Financial situation for the organisation

Chair provided an update on the current finances of the organisation.

With income secured last year from LUSH Digital Fund of ~\$15k, and then taking into account projected expenses of the organisation in 2018, DRW has cash in reserves of \$2k.

# 4. Future workplan of the organisation

Potential future workplan for the organisation.

Continued focus on public awareness activities - media, events, outreach and education. Looking to partner with other orgs wherever possible - EFA have already reached out, continued partnerships with APF, Access Now and academic institutions. Committed projects:

- State of Digital Rights report to be released March TBC
- Melbourne Knowledge Week event (similar to Melbourne Writers Festival event) -May 9
- LUSH fund videos under production
